#### **The CIS MB General Information**

- CIS MB was developed by the BSA's Office of Diversity
- It encourages scouts to explore topics around **DIVERSITY**, **EQUITY**, **INCLUSION** and **ETHICAL LEADERSHIP** and to learn why these qualities are significant.
- Designed to help scouts learn about different identities, characteristics, perspectives, and the <u>lived experiences</u> we each possess.
- Launched on Nov. 1, 2021 and aligned with Scout Oath, Law, and values
- Though it is a MB now available for Scouts to consider, it is not Eagle-Required until July 1, 2022



#### **Facilitating the Citizenship in Society (CIS) MB** is different from counseling other merit badges



#### Here's our plan from the <u>Council Advancement</u> sub-committee:

- Advancement oversees the CIS MB and quality-assures delivery for the best experience that a Scout should have, and in a safe space and safe environment.
- The implementation plan:
  - Part 1: Advancement receive names of interested adult MB Counselors and provides 1-hr special orientation
  - **Part 2**: Then we conduct interviews
    - Those approved go onto a Council list available across 14 districts
    - Part 3: Scouts will sign-up with a <u>yet to be determined on-line scheduler</u> for mixed-troop group discussions overseen by 2 approved CIS MB Counselors
    - Part 4: By end of 2022, the process for this MB will be handled by each District Advancement Chair



GGAC's expectations and steps to becoming an approved CIS <u>MB Counselor</u>

- 1. Meet the following requirements:
  - a.) have current YPT
  - b.) take Diversity, Equity and Inclusion Training for Volunteers: SCO-1800.
    - (Log-in to My. Scouting for the training link)
  - c.) be very familiar with the 11 merit badge requirements and concepts for discussions
  - d.) take GGAC council-presented orientation from Advancement Committee
  - e.) be approved through an interview process (also from Advancement Committee)
  - f.) be registered as MBC (position code 42)
- 2. Will act as a "facilitator" unlike other MBs where Counselors teach and show / EDGE.
- 3. Should not advocate a particular or personal point of view.
- 4. Understand small group study is best for discussions (between 6-8 scouts)
- 5. Know that MB study is not suitable for larger groups or at summer camp
- 6. GGAC Advancement Committee provides the list of approved MB facilitators to Council Registrar

### Stay tuned.

#### To aid CIS MB Facilitators, the Advancement Committee has planned to record a mock Citizen in Society (CIS) Merit Badge Session:

- it will simulate how MB facilitation in a small cohort is done
- with specially trained MB Counselors
- and using18 yr old former scouts as stand-ins for an actual "CIS merit badge discussion group" to express their own thoughts and opinions related to the MB's 11 Requirements
- participants will provide feedback; we will edit recording as necessary
- and allow participants and MB Counselors to approve final content
